#### **World Rules**

The updates to the World Rules for 2022 are highlighted in RED in the new World Waterski Rules and were discussed during the recent E&A Officials Seminar. The main changes that affect Officials are as follows:

- Rule 5.06 Boat Added Weight and Manufacturers Equipment
- Rule 8.13e 4 Judges with Gate and Boat Video Exceptional Circumstances
- Rule 8.15 Boat Path/End Course Video
- Rule 9.06 If a Skier Falls
- Rule 9.13 Release Rope Release
- Rule 10.02 Description of the Jump Ramp
- Rule 13.01 Who may Protest and How it is Done
- Rule 14.07 Site Familiarisation
- Rule 14.12 Entry and Administration
- Rule 14.14 Wild Cards
- Rule 25.08c Survey Jump

All Officials are encouraged to make themselves familiar with these changes and in particular Rule 8.15.

#### **Safety at Events**

The IWWF are in the process of reviewing and updating the Safety Manual and expect the new version to be published before the start of the season. The Manual should be considered in conjunction with the existing Rule 4 in the World and E&A Additional Rules. A presentation about this review can be found here:

## **Judges Tower**



#### **Resources**

National Federations have the responsibility to train and develop National Judges (J3) according to the standards set out in the E&A Additional Rules. For Judges these are:

#### **Minimum Standard**

### a) Level 3 Judges

Sufficient knowledge of the IWWF Waterski Rules and Europe & Africa Additional Rules to judge at Normal homologation competitions and ability to read Tricks to a minimum standard of 1800 point passes – complete runs of 3500 minimums.

### b) Level 3 Judges\*

Sufficient knowledge of the IWWF Waterski Rules and Europe & Africa Additional Rules to judge at Normal homologation competitions in the Slalom and Jump Events.

There are now six Powerpoint presentations available in the Officials section of the Council Website covering a General Introduction and Slalom, Tricks, Jump, Homologation, Judges Duties and Chief Judges Responsibilities that Federations can use and adapt as necessary for training their own officials. #### **Jump Timing Charts**

A small change to the First Segment tolerances for 51k and 54k has been made to address a specific problem that has been reviewed by the World Council.

## **Surepath and End Course Monitoring**

The use of BPMS is mandatory for Record Capability and Ranking List events in 2022. World Rule 8.15 Boat Path/End Course Video has been re-written and the need to monitor Zone Deviation has been removed. Drivers need to be familiar with this Rule and to gain experience driving with these systems



# Homologation and Technology Hub

There are changes in the World Rules that impact on the job of Homologators so please take a look before the season gets underway.

Donal Connolly, creator of Splasheye, has been developing a new approach to trick judging using a new predictive system that should achieve very quick scores. The system is being trialled by a worldwide panel of Judges and the aim is to test it at some events later this year. A demo of the system can be seen here:
