IWWF Show Ski Judging Clinic

In preparations for the <u>2022 IWWF World Show Ski Tournament</u>, to be held in Florida (22nd & 23rd October 2022), the IWWF Show Ski Council will conduct a virtual Show Ski Judging Clinic.

There will be two separate clinics to attend due to the various time zones and all Federations are invited to attend either clinic:

1. One will be scheduled for Pacific/South Pacific time for Australia, China, New Zealand zones:

- 2. One will be scheduled for the **North America/South America/Europe time zones**:

Saturday 11th December 2021 for all local time zones listed

- 9:00 am CST (Central Time North America)
- 10:00 am EST (Eastern Time North America)
- 4:00 pm Europe CET (Central European Time)

Clinic Outline

- Overview: This will be the second clinic in the series for Officials and/or participants. We will review the basics we went through in the first clinic, but more time will be spent on video judging/practice. We will start with a single act at a time similar to the first clinic, but in this second clinic we will build into judging a sequence of acts in order to give better examples of overall judging experience.

 - Video Practice Judging a Sequence of Acts for using "Acts" & "Box Scores" combined (from previous tournaments)
- Summary Wrap Up with Q&A

The majority of the time will be spent applying rules and scoring definitions to actual ski show video scenarios. Interactive video training has proven to be the best method to educating judges in the past when we can't do live in-person training.

I look forward to seeing everyone and having lots of discussion. We will obviously cover the officials roles & responsibilities and spend as much time on "practice" judging via videos of previous shows.
